INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of Tekeyan Centre Fund

We have audited the accompanying financial statements of Tekeyan Centre Fund (hereinafter referred to as the "Fund"), which comprise the balance sheet as of 31 December 2011, and the income statement, statement of changes in equity and cash flow statement for the year then ended, and a summary of significant accounting policies and other explanatory notes.
